The Work Sessions of Oakmont Borough Council for the year 2019 will be held the *first* Monday of each month, except in September, when the Work Session will be held on the first Tuesday, September 3, 2019.

The Regular Meetings of Oakmont Borough Council for the year 2019 will be held the *third* Monday of each month, except in January, when the Regular Meeting will be held on the third Tuesday of that month, on January 22, 2019.

Special Meetings of the Oakmont Borough Council may be held on such days, and at such times, as directed by the President of Council, and will be advertised in advance accordingly.

For the year 2019, regularly scheduled Oakmont Borough board and commission meetings will be held as follows: Carnegie Library Board – second Wednesday of every month (except for February and August) at 6:30 PM in the Library; Civil Service Commission – as needed; Kerr Museum Board – as needed at the Kerr Museum; Oakmont Boulevard Project Board – last Tuesday of each month (except December) at 7:15 PM; Oakmont Planning Commission – Fourth Thursday of each month (except in November, when the Meeting will be held on Thursday, November 29, 2019); Recreation Board – third Wednesday of each month (except July and December); Shade Tree Commission – second Tuesday of January, March, June and September; Zoning Hearing Board – as needed; Property Maintenance Board of Appeals – as needed; and, the UCC Board of Appeals – as needed.
