All meetings will be held in the Council Chambers of the Oakmont Municipal Building, 767 Fifth Street, Oakmont, Pennsylvania 15139 at 7:00 PM prevailing time, unless otherwise noted.

The Reorganization Meeting of Oakmont Borough Council will be held on Tuesday evening, January 2, 2018.

The Work Sessions of Oakmont Borough Council for the year 2018 will be held the *first* Monday of each month, except in January and September, when the Work Sessions will be held on the first Tuesday of those months, on January 2, 2018 and September 4, 2018, respectively.

The Regular Meetings of Oakmont Borough Council for the year 2018 will be held the *third* Monday of each month, except in February, when the Regular Meeting will be held on the third Tuesday of that month, on February 20, 2018.

Special Meetings of the Oakmont Borough Council may be held on such days, and at such times, as directed by the President of Council, and will be advertised in advance accordingly.

For the year 2018, regularly scheduled Oakmont Borough board and commission meetings will be held as follows: Carnegie Library Board – second Wednesday of every month (except for February and August) at 6:30 PM in the Library; Civil Service Commission – as needed; Kerr Museum Board – as needed at the Kerr Museum; Oakmont Boulevard Project Board – last Tuesday of each month (except December) at 7:15 PM; Oakmont Planning Commission – Fourth Thursday of each month (except in November, when the Meeting will be held on Thursday, November 29, 2018); Recreation Board – third Wednesday of each month (except July and December); Shade Tree Commission–second Tuesday of January, March, June and September; Zoning Hearing Board – as needed; Property Maintenance Board of Appeals – as needed; and, the UCC Board of Appeals – as needed.
